Attendance, and Student Code of Conduct

Sixty (60) hours is a NJDOE and NJAC requirement. All HCESC/Franklin rules and regulations are in effect during the summer program. Incidents of disciplinary violations can be considered sufficient grounds for dismissal with no refunds provided.
